**GUARANTEE AND INDEMNITY**

I/We the undersign have requested you to supply .....

1. I/We indemnify the Supplier against any losses, costs, charges and expenses of any nature which it might incur as a result of any default of the Customer.
2. I/We will also be responsible to the Supplier for all outstanding monies due now or at any time in the future for goods which have been supplied or may have been supplied from time to time.
3. Both My/Our indemnity and My/Our Guarantee are continuing security and will not be affected;
  - (a) If the Supplier:-
    - (i) grants any extension of time or other indulgence to the Customer;
    - (ii) refuses further credit to the Customer;
    - (iii) Varies the terms of the Customer's account or the arrangements between the Supplier and the Customer are changed in any other way (even if this increases my liability under this guarantee and indemnity);
  - (b) By the release of any of the guarantors of if this guarantee is unenforceable against any one or more of the guarantors;
  - (c) If any payment by the Customer is later avoided by law.
4. I/We agree that each application for credit made by the Customer to any of you as Supplier shall be deemed to have been accepted from the date of your first invoice to the Customer and without further notice to me this Agreement shall immediately have effect as an Agreement under seal between me and each of you which becomes a Supplier.

6. This guarantee may only be withdrawn by giving you fourteen (14) days notice in writing by certified mail, but will continue in force in respect of all debt incurred by the Customer up to the date of the withdrawal.
